# LETTER FROM THE VECDD CHAIRMAN

Dear Viera East CDD Residents,



I have the pleasure of serving as the Chair of the Board of Supervisors since you elected me in 2020. Thank you for this opportunity. The Board, the entire District team and I are very proud of the progress and results we've delivered for our residents.

Our goal is to provide and maintain high quality public facilities and events for the entire Viera East Community Development District, without indebting our residents with another bond. Our facilities include Woodside Park and Nature Playground, Pieloch Dog Park, walking trails, many acres of preserve and scrub jay habitat, community fire lines and 84 ponds.

After our last newsletter, we achieved the following financial and community goals:

- Since 2020, lowered Viera East CDD taxes by roughly 25%.
- $\bullet \ \ Increased \ capital \ reserves \ to \ over \ \$1.5 \ million \ dollars \ at \ the \ start \ of \ this \ fiscal \ year.$
- $\bullet \ \ Improved \ district \ equipment \ used \ in \ our \ duties \ on \ the \ nature \ preserves, \ park \ and \ golf \ course.$
- Significantly remodeled and repaired our infrastructure, including the golf course clubhouse, restaurant, pro shop, irrigation systems at the park and golf course.
- Maintained high net revenues to meet our goal of self-sufficiency for the golf course.
- Continued our annual nature preserve firebreak clearing, an alternate plan to controlled burns.
- $\bullet \ \ Developed \ a \ district \ culvert/flow \ way \ map, \ and \ plan \ for \ annual \ inspection.$
- Hosted weekly and monthly community events at Hook & Eagle Tavern, including Wing, Burger and Karaoke nights and Music on the Patio. Always open to the public.
- Maintain the monthly Viera East Farmer's Market at Woodside Park.

I'd like to thank fellow Board members Jennifer De Vries, Bill Macheras, Ron Rysztogi, and Denise Yelvington for their service to the community. I also thank the incredible team of people who work tirelessly to maintain our facilities and serve our residents and patrons. We couldn't do what we do without our staff, so when you see them at the Dog Park - Hook and Eagle - Golf Course - Nature Preserves etc., please acknowledge their hard work and dedication.


# FISCAL REPORT

The district has experienced very large expense increases over the past three years. Minimum wage increase requirements, fuel, equipment, golf course maintenance supplies and restaurant food costs have increased dramatically, and in some cases, tripled due to economic conditions. Heavy rains in January & February cost the golf course several hundred thousand dollars in gross revenue. Despite the tough economy and weather issues, gross income has increased for the past three years.

Annual golf course **net income** the past 3 years is still the highest since district inception, but has been impacted by expenses. We expect to finish 2024 in a good position. The golf course now meets the board's expectation of being self-sustaining. Excess golf course revenues go to capital savings, with the goal of eliminating the need to ever require another District bond for capital infrastructure like roofs, equipment, etc.

Revenue collected from CDD assessments does not support the golf course. CDD assessments pay for our waterways, nature preserves, parks, trails, and are also used to build our reserves in the event of an emergency such as a hurricane. Viera East CDD assessments have decreased 26% over the past 3 years.


### VIERA EAST MARKET

# FIRE BREAK MANAGEMENT

District Nature Preserve fire break and preserve fire management is a top priority in VECDD servicing. To help accomplish this firebreak mission the district uses a FECON mulcher and tracked vehicle. The FECON purchase helps save the district annually roughly \$10,000 of money previously allocated for controlled burns. This process also prevents burn-related air pollution

The 2024 fire break cutting is now complete, ahead of schedule, with the exception of those homeowners living in Auburn Lakes and Herons Landing communities bordering Scrub Jay habitats. Scrub Jay nesting season runs from March through June. There was a delay in the firebreak schedule due to heavy rains in January and February which led to saturated conditions in the firebreak areas. The remaining 2 communities will be completed as weather and conditions allow, after June 30th nesting season.







YARD WASTE DANGER

We need your help! Please keep yard and other waste away from and out of storm drains and ponds. The best way to prevent flooding is to keep the drains free of debris.

**BE WATERWAY CONSCIOUS** - Do NOT place yard waste for pickup on top of or next to storm drains. In 2022, during Hurricane Ian, one of our Viera East neighborhoods had street and yard flooding. After a day of research, our District Engineer removed a large cut oak branch, covered in palm branches, from a Brevard County storm drain. Once the debris was removed, the water in the streets drained away quickly.

As hurricane season approaches, let's work together to keep our storm drains clear by keeping yard waste out of our drains and ponds.

#### When the drains are:

- Clear the water drains to the St. John's River
- Blocked the water goes into the streets, then your yard, and possibily your home

## VECDD WATERWAYS

Pond care - The CDD employs a service, including a degreed biologist, to properly care for our ponds. This service treats the ponds to reduce insects, algae, emergent plants, floating and submerged plants. One of the insects we encounter are aquatic midges, Midges are non-biting, flying insects that emerge from ponds in swarms during certain months. Midges lay their eggs on top of the water and the eggs sink to the bottom and become larva. One way we control midges is by stocking the ponds with catfish, who eat the larva at the bottom of the pond. By having the fish eat the larva, the midges never emerge as flying insects. If you see catfish in the pond, they may be helping to keep the insects away!







# VECDD WATERWAYS CONT.

Keep Pond Edge Plantings in Place - A littoral zone is the downward slope of a pond or a lake. The plants along the edge of the pond help maintain the boundaries of the pond, alleviating some of the need for lakeshore restoration. Littoral plants provide shelter and nutrients to aquatic life too. Most importantly, they help filter debris and unwanted nutrients. Help us keep our littoral shelf plantings. Contact our CDD General Manager if your community wants to aid in expanding these plants.
